<i>Foundations II: Board Candidate</i> Board Resume + Board Bio + LinkedIn Profile Two (2) additional hours of board candidacy, interview prep or related support over up to three (3) months	
<i>Foundations II: Board & Executive Candidate</i> Board Resume + Executive Resume + Board Bio + LinkedIn Profile	

Note: The Foundations I and II Suites are each billed as a flat fee and equivalent to 12 or 15 coaching hours, respectively. If you are seeking a service that doesn't exactly match what is listed here, please contact Anne Marie to discuss additional options.

Coaching Plans

A Coaching Plan may be the right choice if you seek structure, accountability and a safe space to increase ownership of your career, vet professional and life decisions, design evolving next steps, overcome challenges and cultivate greater perspective, awareness and calm.

<i>Foundations I: Coaching</i> Twelve (12) coaching hours over up to six (6) months	\$5,900
<i>Foundations II: Coaching</i> Fifteen (15) coaching hours over up to nine (9) months	\$7,125
<i>Silver Plan</i> Twenty-five (25) coaching and/or writing hours over up to fourteen (14) months	\$11,250
<i>Gold Plan</i> Thirty-five (36) coaching and/or writing hours over up to eighteen (18) months	\$15,000
<i>Platinum Plan</i> Forty-eight (48) coaching and/or writing hours over up to twenty-four (24) months	\$20,000

Note: The extended plans offered above are best for biweekly coaching arrangements, corporate outplacements or other situations that are best served by an in-depth, sustained engagement.

Plans may be devoted entirely to weekly or other periodic coaching sessions or can be structured to include document drafting (e.g., resume or professional bio) as part of the time available.
